- Financial Policy
 - Option 1: financial committee comprised of members present at business meeting
 - Option 2: financial committee comprised of seneschal, exchequer, and 3 populace members
 - Alys:
 - Option 2 Section 7b: Don't need to list all legers, statements, etc. All other Baronies simply list that reports must be "per kingdom financial policy"
 - □ Option 2 Section b14: Adding coronets to homowners or renter's insurance not present in other barony's policies
 - As it's just a suggestion in the policy, we cannot enforce it. Additionally, the baronial coronets are not valued high enough to be insured.
 - □ Option 2 Section 11g: physical inventory posted in baronial newsletter
 - ◆ Don't think we need to bog down newsletter with inventory
 - Copy provided upon request and on website?
 - Printing special edition newsletter once a year?
 - Not required to be published
 - Fresh inventory each November is a good idea, so it's current for the Domesday
 - David:
 - Is the financial committee the members at a populace, or the selected individuals?
 - o Stefan:
 - What do other baronies do for their financial policy composition?
 - Alys: most frequently: populace present at the business meeting + seneschal & exchequer
 - □ Kale: 3 options are: entire populace, populace at the meeting, or select individuals.
 - Kale:
 - One issue with populace or populace at a meeting is verifying current membership.
 - Jennifer:
 - We have verified membership and age previously at meetings, it's always been required, but hasn't been a big issue.
 - o Dave:
 - Will it be more efficient to have the populace at the meeting, or a select committee?
 - Fluffy:
 - Financial items should be announced before the meeting.
 - It should never be in the hands of the select few because the rest of us would have no say.
 - Allen:
 - Pros & Cons of both ways:
 - ☐ If it's not working, we can change it.
 - □ Pros: Option 1 (populace at meeting): we already have a small attendance, with some already saying they don't know what the barony's spending. This allows people to feel some control & buy-in.
 - □ Cons: Option 1: mob rule, 2 competing bids can cause hurt feelings.
 - Addressed by Bid committee prior to presentation at meetign
 - □ Con: Option 2 (select few): 3/5 is a majority, so they can overrule the will of the populace.
 - Pro: Option 2 (select few): simple and easy and convenient to go through. Occurs

outside the meeting, keeping meetings from dragging on.
